

## Terms and Conditions of Bond:

*"You are in custody of the Court by reason of your recent indictment by the state of \_\_\_\_\_. Your rights are restricted until your bond is terminated. As a defendant, you can be arrested without a warrant by any Bail Agent of Andy Callif/FianZa Bail Bonds or any other police authority, whenever there are reasonable grounds to believe that you have violated the terms and conditions of your bond."*

**The following are the conditions that apply to any and all defendants released by means of a bond agreement:**

- *Within 72 hours of release, the defendant must come into the office in order to complete paperwork and agree to bond conditions. At this meeting a photo of the defendant will be taken, along with a copy of their ID if applicable.*
- *The defendant may be required to make check-ins by means of phone call, walk-in, phone application, ankle monitoring (at you cost) or etc.; however ALL defendants are required to check in after each court date.*
- *If it is deemed necessary by the bond amount a debit/credit card will be placed on file with a predetermined amount to be charged every month on a set date.*
- *Trouble should be avoided and places where other violate the law should be avoided as well.*
- *All orders issued by the Court must be obeyed, including stay away orders and as well as any State laws or City/Village ordinances.*
- *During the term of the bond good behavior and civility must be practiced.*
- *Any change in address, phone number, or employment must be reported to the agency.*
- *If a holder is added after the bond is posted preventing the defendant from release, monies paid will be returned; however there is a processing fee that will vary depending on bond amount/location that will not be returned, also any payments made are directed toward the balances of any and all past bonds.*

**ANY VIOLATIONS OF RULES OR CONDITIONS OF THE BOND WILL RESULT IN REVOCATION OF THE BOND AND THE DEFENDANT WILL BE REMANDED BACK TO THE CUSTODY OF THE JAIL.**

*I have read and understand the above orders. I understand that violating any of the aforementioned orders will result in the revocation of the bond without entitlement to the refund of monies paid.*
